### Defining and improving population health

Right now, a number of policy developments are causing population health to have an increasingly high profile. The Kings Fund states, in their report [What does improving population health really mean?](#) the phrase ‘population health’ is used to convey a way of conceiving health that includes the whole range of determinants of health and wellbeing – many of which, such as town planning or education, are quite separate from health services. The phrase ‘Population health management (PHM)’ is also widely used, with a specific meaning that is narrower in focus than population health, and refers to ways of bringing together health-related data to identify a specific population that health services may then prioritise.

The NHS Long Term Plan, published in January 2019, reconfirms the need for the NHS to move from reactive care towards a model that embodies proactive population health management and expects NHS organisations to do this through the creation of new Integrated Care Systems. In the report [The transition to integrated care: population health management in England.](#) by The Deloitte Centre for Health Solutions, they identify four building blocks (infrastructure, insight, interventions and impacts) and nine critical success factors for achieving better PHM, and support the significant change in culture, the deployment of new financial incentives and performance metrics.

**Infrastructure**

-  Having a shared vision, mission, and understanding of how to implement PHM
-  Leadership maturity and good governance
-  Improved shared technology and infrastructure

**Insight**

-  Focused population targeting and segmentation
-  Robust systems of monitoring, advanced analytics and insight process

**Intervention**

-  Aligned financial model and funding incentives across the system
-  New approaches to delivery and workflow
-  Delivery of primary care at scale

**Impacts**

-  Population engagement and patient activation








### What can I do with KnowledgeShare?
